NOTIFICATION

The Government of Puducherry has reconstituted the Fee Committee under the Chairmanship of Hon'ble Justice S. Rajeswaran, Judge (Retired), vide GO read (1) above to fix /determine the fee structure in unaided Private Professional Educational Institutions of this Union Territory of Puducherry.

2. The Fee Committee under the Chairmanship of Hon'ble Justice S. Rajeswaran, Judge (Retired) has fixed the following final fee structure for Post Graduate Medical and Dental Courses for the years 2017-18 and 2018-19.

3. Accordingly, the Hon'ble Lieutenant Governor of Puducherry is pleased to approve the above fee structure for admission of students in Post Graduate Medical and Dental Courses for the years 2017-18 and 2018-19, subject to the following conditions:

- a. The fee structure prescribed above shall be applicable for the two Academic Years 2017-18 and 2018-19 respectively.
- b. This fee is an all inclusive annual fee including various fees like admission fee, Tuition fee, Special fee, Laboratory / Computer / Maintenance and Amenities fee, Extracurricular activities fee and the other recurring expenditure.
- c. In addition to the above fee, the institutions are permitted to collect an amount of Rs.50,000/- per student as development fee.
- d. The management is directed to cover all the students under Students Group Insurance Scheme.
- e. The above fee does not include Hostel, Transport and the Mess charges.
- f. The Committee directs that the institution shall not charge either directly or indirectly any other amount over and above the amount fixed as fees. If any other amount is charged under any other head or guise, e.g. donations, the same would amount to charging of capitation.
- g. Any deviations of this order will entail serious penal consequences like, withdrawal of approval of MCI, cancellation of the Essentiality Certificate issued by the Government of Puducherry and disaffiliation by the concerned University as well as imposition of fine.
